### About the Steering Committee

The Steering Committee is responsible for overall policy and direction for the Network, and meets approximately quarterly by teleconference. The Steering Committee will meet face-to-face for the UNCG Business meeting during the June 2017 conference.

Steering Committee members are expected to support UNCG projects and functions, through serving on a subcommittee, recruiting new members, or contributing as leadership to the UNCG Network.

Makeup of the Steering Committee: UNCG is interested in maintaining a geographically and institutionally diverse committee. Committee members receive no compensation.

The Nominating Committee is making individual as well as email inquiries about potential nominations during this period. A slate will be presented for election via electronic ballot in May.

The Steering Committee will convene with new members at the UNCG Business Meeting in June 2017 and select a chair, vice chair, treasurer, and member outreach chair. The former chair moves into the role of past-chair.

Officers' duties are as follows:

- The Chair will convene meetings and serve as an ex-officio member of the KTD Board, with invitations to attend their two annual meetings and have travel expenses reimbursed.
- The Vice Chair will assist the Chair and be responsible for recording Steering Committee actions.
- The Treasurer shall coordinate, when needed, with KTD in its capacity as fiscal agent, and make a report at each Steering Committee meeting and at the annual meeting on membership, dues and other financial information.
- The Membership Outreach Chair will recruit new members.

- The Past Chair will lead the nomination committee and serve as a resource for the Steering Committee.
